I understand and accept the following:

- A membership card or pass is required for entry to The Funhouse and is not transferable or refundable.
- Children under age 9 must be accompanied by a responsible adult or guardian.
- The Funhouse is not a licensed child or daycare facility, has an "open door" policy allowing children to come and go freely, and accepts no responsibility for keeping children in the building or on the premises or after hours if rides are late.
- Due to budget limitations, The Funhouse will operate with minimal paid staffing and will rely heavily on volunteers. As such, children may not be under constant supervision (parents are encouraged to accompany their kids).
- Backpacks, large bags, food and drink are not allowed in the building past the entry vestibule
- Memberships may be revoked if illegal, dangerous, or inappropriate behavior, as determined by The Funhouse, is exhibited while on the premises or grounds (in which case prorated membership fees will be refunded.) The Funhouse staff and/or volunteers reserve the right to ask anyone to leave The Funhouse at any time for any reason.
- I have inspected the grounds (including the playground) and the indoor facility (including the climbing wall, pitching cage & nautical fort) and find them to be safe for me and/or my children to visit and use, as they pertain both to potential physical dangers and to the safety of the building layout as regards potential sexual abuse. I understand that I and/or my children use The Funhouse and grounds at our own risk and that where children play, there is usually increased potential for mishap.
- Our Internet stations employ "watchdog" software programs designed to keep inappropriate material from minors. It is impossible, however, to unconditionally safeguard against all such possibilities in spite of the efforts and intentions of The Funhouse and I accept this risk in order that members may have access to the tools of the Internet.
- There are interior and exterior security cameras (none in bathrooms) that record activities 24 hours/day.
- In the case of emergency, I allow The Funhouse staff to summon medical attention for my child and/or myself and I agree to be financially responsible for any resultant medical expenses. The Funhouse will try to reach parents as soon as possible.
